## **SCHOOL FEES 2022**

It has been approved at the Annual General Meeting of the School Governing Body held on Monday, 29<sup>th</sup> November 2021 that:

1. The Annual School Fees per learner, for Edenglen Primary School for the 2022 Academic year shall be:
  - **R21,780 per annum**
  
2. The payment structure of the 2022 school fees shall be:
  - Gr 1-7: R1,980 x 11 months = R21,780
  
3. No Registration Fee will be charged for learners returning in the 2022 Academic year, however, should a parent wish to pay the first month's fees for 2022 upfront, this will be welcomed and allocated to your account accordingly:
  - Gr's 1-7: **R1,980**
  
4. A **12% Early Settlement Discount** is offered on upfront annual payments, provided that:
  - The full annual payment is made by 31<sup>st</sup> January 2022 – **R19,166.40**
  - The payment is done via EFT or debit/credit card facility at the School (no cash deposits).
  - The school fee account for prior years is up to date.
  
5. **Important information:**
  - a) School fees are due and payable annually in advance at the beginning of each school year and such payment is a statutory duty, which a learner's parents must pay and the parents (as defined in the South African Schools Act) whether married, unmarried or divorced, are jointly and severally liable unless and to the extent of them being exempted.

- b) However, purely in order to reduce the financial burden on parents, ELEVEN equal instalments for Gr 1 to 7 learners, commencing in January 2022 and ending in November 2022, will be acceptable. Any other payment arrangements must be approved, in writing, by the Finance Committee.
- c) Failure to pay any single instalment by the due date will mean that the full 2022 School Fee amount becomes due and payable immediately.
- d) Parents who wish to be exempted from the payment of school fees must apply annually to the School Governing Body (applications open 1<sup>st</sup> February 2022, and close 28<sup>th</sup> February 2022).
- e) The income of BOTH parents, irrespective of their marital status, is used in the calculation of the exemption.
- f) The School Governing Body reserves the right to ask for any supporting documentation that they may deem necessary in assessing the exemption application, and the school may conduct credit checks with a listed credit bureau.
- g) A maintenance agreement or divorce order cannot be enforced on a third party, being the School.
- h) School Fees are a statutory debt prescribed by parliament under the South African Schools Act, and do not fall within the National Credit Act 34 of 2005 and, as a result, may not be referred to a debt counsellor for debt review.
